Children having their say

The Tameside Participation Project is run by 4Children for Tameside local authority. The aim of the project is to ensure that children and young people have their say and can actively contribute to the development of services such as play, health and out of school activities in Tameside.



The Participation Project uses creative approaches to deliver many different initiatives including school council training and the involvement of children and young people in recruitment and commissioning, consulting about and evaluating local services. These are all things that children and young people identified as being priorities to them, thus the project is having a real impact on their lives.

Children who become more involved in services develop more confidence and greater engagement with their community. Developing school councils has supported children to tackle issues such as bullying, transition from primary school and healthy living.

Children and young people contributed their views to the Tameside Children and Young People's Plan and produced their own child friendly version of the Plan. They commented, *"We feel this plan makes sense... it will give us a better chance of being healthy, safe, listened to and more involved, and to encourage us to be the best we can be."*

The project also provides consultancy to partner agencies on innovative methods of engaging children and young people. The Tameside Participation Project and 4Children are only able to support children's involvement in developing services to meet their needs with your help – thank you so much.

Making sure the service is Fit for Purpose

Amanda, a rising 17 year old was rushed to hospital with suspected meningitis. Unfortunately, no information followed the patient and she was placed on a mixed ward for the elderly where 10 separate nurses examined her, forming their own conclusions regarding her condition without ever referring back to her.

Amanda's parents were not allowed to be with her and subsequently, during the night she was continually disturbed by a male patient with a form of dementia who needed continual care. She was unable to look after herself and unable to drink because of the machines attached to her and her drinks being placed out of reach. She was discharged mid-morning

the following day with tablets for a severe water infection and no follow-up information.

This is a short story of a young person who has received poor quality care. Action for Sick Children was specially formed to help people such as Amanda receive the highest quality of care. Her experience is totally unacceptable in 2010 and Government guidelines frown upon young people being placed in mixed geriatric wards.

Action for Sick Children is still required to help with attitudes and training for those working with children and young people in order that they receive appropriate care in appropriate conditions and we are grateful for your support in this – thank you.

BAAF celebrates our 30th anniversary in 2010. We have been finding families for children in care and providing essential advice and support to everyone affected by adoption or fostering since 1980.



Our pioneering projects have changed the landscape of how services for children and young people are delivered. For example, Be My Parent has linked more than 5,000 children with families over 30 years and our adoption, search and reunion website has helped thousands of adopted people locate their adoption records and begin to search for birth relatives.

We have campaigned for much-needed improvement and effectiveness in adoption and fostering services. For example, we helped persuade the Government to allow unmarried couples, including same-sex couples, the right to apply to adopt. Over the past 30 years, millions of professionals, adopters, carers and others have looked to us to provide knowledge, skills and understanding. BAAF is the largest specialist publisher in the UK of books on adoption and fostering and more than a million people have used our telephone and email enquiry service.

Our work would not be possible without our supporters. You have enabled us to find families for thousands of children in care - children who need and deserve safe, permanent, loving families as much as any child does - thank you so much.

Moving On

Working Families' Waving not drowning network for parents of disabled children has its work cut out.

We floated the idea of a 'transition' publication with the Waving not drowning network of parents of disabled children who work or wish to work and the replies came flooding in:

- It is hard enough to juggle work and school but the transition to adulthood is a different challenge again.
- We are about to embark on transition. My son will need ongoing support into adult life.
- My severely multi-disabled son is 24 and we still find that there's work to be done on his behalf.
- The benefits system has been a nightmare.
- Transferring to adult Disability Living Allowance at 16 was very difficult.
- I have changed my job and gone self employed as my son is now in FE. When he was at school it was difficult, now it is impossible.

Staying put



'Did you know that the average age for someone who is not in care to leave home is 24?'



Current arrangements in foster care mean that young people in care no longer have the support of local authorities the moment they reach 18.

Amy, a care leaver says *'The reality is that when you hit 18 you get nothing. One minute you have lots of support and the next it's gone.'*

Foster carers will cease to receive support from their local authority once the child in their care reaches 18, resulting in many young people not being able to stay on for financial reasons. Care leavers are vulnerable and need ongoing support.

The Fostering Network's project - Leading our Lives - allows young people to have a genuine voice in discussions around their own future and the services affecting them. They produce a newsletter, REVO, which offers information and advice to 20,000 young people who have had an experience of fostering, including those about to leave care. They also campaign for the changes needed in foster care.

The Fostering Network also supports the Staying Put scheme, currently being piloted in ten local authorities, and which offers young people the opportunity to stay on in foster care beyond the age of 18 and up to 21.

The pilot schemes are due to finish in 2011, and will hopefully mean that more young people will have the opportunity to stay with their foster carers. This will provide a safe, secure and nurturing family environment at an important time for a young person, as they prepare for the transition to adult life. Thank you for helping us to achieve this.

So, we've recruited an advisory panel of Waving not drowning members and disabled young people. The plan is to provide information about how family finances alter when your disabled child becomes a young adult. Parents may lose benefits. Young people may become entitled to them in their own right at age 16, 17, 18 or older. Parents may need to change their work patterns in order to support their son or daughter visiting the Jobcentre or in finding personal assistants. All that is left to do is find the funding to plug the transition information gap. And we're sure that with your ongoing support, we will be able to realise this - thank you so much.

outside pubs where people are enjoying a few pints! But I was glad to raise as much as possible and I'm still expecting a few people to get back to me in the next few days'

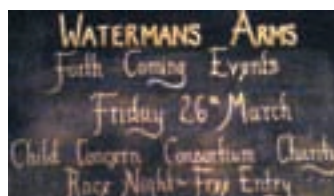

Many thanks to **Paul** and **Connie** for organising such a great night out at The Watermans Arms, Docklands in support of Child Concern Consortium.



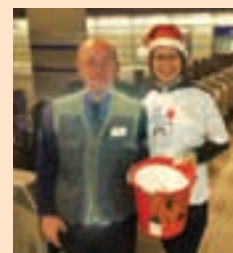
